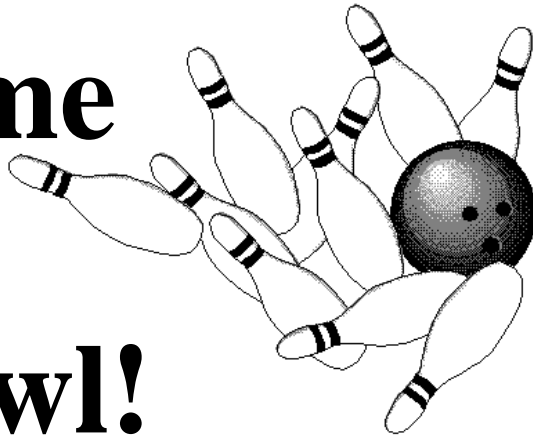

League Officers' Tournament Rules

1. This tournament is certified by the United States Bowling Congress.
2. Only officers of Certified Leagues are eligible to enter.
3. Each entrant may enter **only once**.
4. This is a **Pins Over Average Tournament**.
5. It shall be each entrant's responsibility to verify the accuracy of his/her average, whether originally submitted by the bowler, the team captain or others. Failure to use the correct average or make a correction prior to, or at the time of bowling could result in disqualification. If the submitted average is lower than his/her correct average, he/she will be disqualified. If the submitted average is higher than the correct average, winnings will be based on the submitted average. **(Rule 319a-3)**
6. **USBC Rule 319C** (Average Re-rate) and **USBC Rule 319D** (Reporting of \$600 Prize in any event) are strictly adhered to. It is each entrant's responsibility to comply with these rules. Failure to comply with either shall result in forfeiture of tournament fees and prize winnings.
7. **ONLY the President, 1 Vice President, Secretary, Treasurer or 1 Sgt. at Arms per league are eligible.**
8. This is a one day tournament, starting and ending on April 19, 2008.
9. Bowlers must use their highest 2006/2007 certified average to compete in this tournament. If a bowler does not have a 2006/2007 average, the current average for 21 games or more as of December 1, 2007 will apply. Anyone not having a certified average will bowl scratch at 210.
10. USBC rule **(319e)** will apply in this tournament. Rule **(319a-2)** and **(319a-3)** will apply.
11. Entry fee \$7.00 per bowler for expenses only. All prize fund disbursements to be made by the Chicagoland USBC Association with a ratio of one in ten.
